



## Tioga County Fair Camping Rules, Regulations, and Disclaimers

- **Enter and Exit Fairgrounds:** Use Elm Street Only
- **Check In:** Monday, August 5<sup>th</sup> between 11 AM and 8 PM or Tuesday, August 6<sup>th</sup> between 9 AM and Noon.
  - *Check in with Fair Office to secure:*
  - *Site Assignment*
  - *“Camper Vehicle Parking Permit” – Must be displayed on vehicle dash*
  - *Camping Permit Card – Must be visible in window of camper or nearest door*
- **Parking:** One (1) parking permit per site; all others must park in general parking
  - *No Stock Trailers in Camping Area; Stock trailers must be parked in overflow parking field.*
  - *Golf Carts, motor bikes, ATVs, or similar motorized vehicles are prohibited.*
  - *Parking will be strictly enforced due to space and safety*
- **Animals:** Pets are not permitted on the fairgrounds or at campsite
- **Visitors:** Must have purchased a Fair Wrist Band are permitted in Camping Area
- **Electricity:** Electric cords may not cross roadways; One (1) electric outlet per camp site
- **Generators:** Generators must have a Decibel rating below 50 (dB).
  - *Campers will be asked to disconnect generators over 50 dB.*
  - *If a second request is made, the camper will be asked to leave the Fairgrounds.*
- **Alcoholic Beverages:** Not permitted in camping area
- **Quiet Time:** 11 PM to 8 AM daily
- **Trash:** All trash must be placed in dumpster by 8:30 AM daily
- **Site Maintenance:** Site and fixtures must be clean and in safe condition.
  - *Dispose of trash, rubbish, and other waste in a safe manner, to the location identified by the Fairgrounds.*
  - *Use electrical, plumbing, other facilities and appliances in a reasonable manner.*
- **Gray Water/Sewage:** Must be handled appropriately (no dumping on ground).
  - *Anyone found abusing this rule will forfeit their camping privileges*
- **Age Minimum:** Must be 21 years of age to register for a camp site.
  - *Registrant is responsible for all occupants and guests at the assigned site, including damage to any part of the campground*
- **Check Out:** Sunday, August 11<sup>th</sup>, 9 AM
